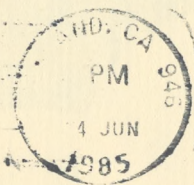





Some meditations on the invoice.....


On my original estimate of November 4, we assumed (before I saw the manuscript) that we would be getting 140 pages with an average of 300 words to the page, or 42,000 words. The actual manuscript had 47,628 words. You also turned down the original design and asked for a larger type size. Both of these changes resulted in more typesetting and more pages than anticipated. Despite this, our invoice for typesetting and production (\$1735.00) and Nancy's invoice (\$1280) comes within \$100 of our original estimate, so I feel good about this.

What the extra typesetting and page count has meant, though, is that instead of a 128 page book that we originally estimated, the book will be 152 pages, which will result (as I previously warned you) in a higher printing bill than originally thought. I'm enclosing the revised estimate from Edwards Brothers, so you can be forewarned.

I've got some killer bills coming up at the end of this month, so (dear friend) if you have money sitting around in a bank account somewhere, I could truly use it.

I'm still working on the bid for the Bali Book. Let's have lunch together whenever you're in town.



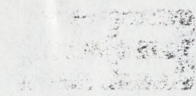

As you can see - perhaps a bit too clearly - the major expenses are in getting it on the presses, which is reflected in the first 1,000 copies. After that it's only about 60¢ a book.

It looks to me - without knowing anything about your cash flow - that you should be reprinting at least 2,000, probably 3,000. Piece of Mine not only has inertia of its own, but I think you'll see a climb in sales of Piece of Mine when Billy's Bar-B-Que comes out and broadens the publicity of the press as a whole. Best,
