**** CONSIGNMENT TERMS ****

The following outline represents the standard consignment/sales arrangement for the purchase of smaller press titles by the Distributors:

1. Books must be billed at a discount of 55% off retail price, freight prepaid.
2. Publishers will receive consignment reports on a monthly basis. These reports will include a listing of:

TITLE AND PRICE OF EACH BOOK
BEGINNING AND ENDING INVENTORY
BOOKS RECEIVED OR RETURNED FROM PUBLISHER
NUMBER OF BOOKS SOLD DURING MONTH REPORTED
PRICE EXTENSION OF BOOKS SOLD
TOTAL DUE LESS DISCOUNT FOR BOOKS SOLD

3. Reports are to be generated and mailed approximately 35-40 days after the close of each month. This will allow sufficient time for the payments to be enclosed with the report. (On purchases to be re-shipped to the national chain stores, the Distributors reserves the right to hold back portions of the payment beyond the normal 35-40 day period). For example, the January Sales Report will include all transactions for the month of January 1st through January 31st and will be mailed approximately March 5th-10th.

4. If there is no sales activity on a monthly report, that report will be held to be mailed with the following report. No more than three reports will be held at any time.

5. Upon the discovery of defective or damaged books, returns may be made at the publisher's expense. Requests in writing for the return of overstock books must be made and shipping will be at the publisher's expense.

6. When continued stocking of a title is no longer justified (ie., lack of any sales activity), the books may be returned and the title discontinued.

If we can be of further assistance or if you should have any questions regarding the consignment/sales arrangement, please do not hesitate to call or write. PLEASE MAKE SURE THAT YOU UNDERSTAND THE ABOVE ARRANGEMENT PRIOR TO PROCESSING A PURCHASE ORDER FROM THE DISTRIBUTORS.
