FOLKTALES

THE SPIRIT JOURNEY: Stories and Paintings of Bali by Madi Kertonegoro

I am a magical being, unseen by the eyes. Sometimes those with special powers can feel my presence. Spirit is my name. I can go anywhere I want. I am not restricted by space. Not a secret in the world is a secret to me.

And if you follow Spirit on his journey across the island of Bali you too will be able to see into the hearts and souls of its people. You'll witness the annual "wars" in which boys fight duels using sword-sharp pandan leaves as weapons, meet a youth who runs amok with a magical *kris* (dagger), and hear the origins of both a Tenganan village and of the *Bali Aga* people (the "original Balinese") who lived there.

All these are traditional Balinese stories whose written manuscripts were destroyed in a fire in 1841. They lived on in oral tradition, however, and Javanese artist Madi Kertonegoro retrieved and preserved them in this small, magical volume, **The Spirit Journey**. Illustrated with traditional *Lontar* palm-leaf drawings, the tales offer a peek at both ancient and modern Bali.

An additional section of color plates reproduces an eclectic selection of ten of Kertonegoro's paintings, including a self-portrait, a pastoral Balinese scene, and several with anti-war themes.

Alice Walker (*The Color Purple*) expresses a hope in her introduction to **The Spirit Journey** that the book "will serve to help bring the people of our country, the United States of North America, closer to the people of Bali, Indonesia, a people [with] cultural integrity, personal gentleness, and courtesy. . ." It seems certain that this, the only book of Balinese folklore written by an Indonesian and published in English, is sure to achieve this end.

TALES FROM THAILAND: Folklore, Culture and History by Marian Davies Toth

Thailand—the very name conjures up exotic images of dancing girls, jungle animals, and a culture steeped in Buddhist tradition. **Tales from Thailand** is inspired by this exoticism and seeks to penetrate its mystery.

The stories tell of the ancient days when gods still spoke to men, of the battles of noble kings, of animals that talk, of hunters and farmers.

Toth, an educational consultant and administrator, collected and compiled these eighteen tales while teaching creative writing at the International School in Bangkok. Her experiences impressed upon her the impact these tales and traditions have on modern Thailand, and her book emphasizes that these legends are still very much a part of everyday village life. For "these stories have helped to bind the people together; at the same time they have given the Thai strength, courage and faith in themselves."

The stories include how-it-came-to-be myths, tales of the Thai people, animal and bird stories. Young children will enjoy having the stories read to them, older ones will find the language simple enough for them to read for themselves and adults will appreciate the insight they lend to the history and culture of Thailand.

"Some day," Toth writes, "readers of this book may travel to the exotic city of Bangkok and visit the Emerald Buddha. In the outer courtyard of Wat Pra Keo they will slip off their shoes, and their bare feet will touch the cold stone steps leading to the sculptured entrance of the temple . . . Through the slated sunlight they will see the 'Heart of Thailand,' resplendent in a gown of jewels." And they will have an understanding and appreciation for it all they didn't have before reading **Tales from Thailand**.

In 1853 John Turnbull Thomson, seventeen years old, arrived in Malaysia. After four years working in the jungles and learning fluent Malay, he was appointed government surveyor of Singapore. **Glimpses into Life in Malayan Lands** is his memoir of that time. His aim, he says, was "to give an illustration of the Far East social system as I found it." To this end he takes us to a gamelan concert at sea off Singapore, a *kenduri* in Penang, a Eurasian home in Malacca, a rural village in Malaya.







SYNTHESIS AND CREATIVITY
IN THE ARTS OF THE FUTURE

INVITATION FOR A SECOND
CONFERENCE ON ART AND THE FUTURE

1. *The First Conference 10 Years Ago*

It has been ten years since the First International Conference on Art and the Future took place in Indonesia from the 8th until the 14th of July 1978. It was attended by artists, lecturers on Art and Culture, thinkers and intellectuals at large from around the world. The conference gathered 2 days in Jakarta, 2 days in Yogyakarta, 3 days in the futuristic Art Center Balai Seni Toyabungkah, Lake Batur, Bali and the closing day on the 14th of July in Denpasar.

During the conference were discussed the problems and possibilities of art as a medium for creating a positive future in its broadest sense by participants from Japan, India, Thailand, Malaysia, Singapore, Germany, Swizerland, France, Britain, Morocco, Romania. About 20 papers were submitted on the following subjects:

1. Art as an Experience and Vision of the Future.
2. Cultural Identity and the Future of Art.
3. Search for the Values of the Future and the Art of the Future.
4. Traditional Art and the Future.
5. Modern Art and the Art of the Future.

During the conference at the Art Center Balai Seni Toyabungkah the participants unanimously agreed to establish the *International Association for Art and the Future*.

A report of the first conference on Art and the Future with the papers of the participants has been published beside a dozen Newsletters on Art and the Future. Although it has not been possible to arrange meetings of the International Association for Art and the Future thus far, the interest for the Association has steadily been growing during these last years. In California a branch of the Association has been established under the leadership of Susanne Frieder Wallock, while discussions are underway for the establishment of another branch in New Delhi, India and in Sydney, Australia.

Meanwhile the activities of the Center for Art and the Future in Toyabungkah, the Headquarters of the International Association, continue to create new expressions of art and the future. About 10 new dances and dramas have been created.

Since 1983 a continuous cooperation between American artists under William Pennell Rock and Indonesian artists has taken place. A dance drama *Emergence* (see Newsletter 9/10) was created and performed in 1983 in Balai Seni Toyabungkah and Ubud. At the end of March 1988 *Emergence* was performed again by students of the Academy of Art *Asti*, twice in Toyabungkah and twice at the Art Center *Werdī Budaya* in Denpasar in perfected form with great success (see Newsletter *Art and the Future* 13/14 page 106 and Indonesia Magazine no. 3/XVII/1987 page 38-44).

Another Dance drama *Convergence* was performed in April 1987, twice in Toyabungkah, twice in Ubud, once in Legian and once in the main Art Center *Werdī Budaya* by 10 American and 15 Indonesian artists.

In 1982 a painting exhibition was held at the renowned Art Center Taman Ismail Marzuki in Jakarta with themes of the Future.

In 1985 the conference of Southeast Asian writers took place in the Art Center in which participated writers from Thailand, Malaysia, Singapore, the Philippines and Indonesia. During the years many interested artists, thinkers and intellectuals visited the Art Center Toyabungkah and had discussions with the chairman of the Association.

2. *Toward A Second Conference in November 1988*

We are writing to invite you to participate in a second conference to be held in November 1988 in Bali, Indonesia.

During the years since the first conference, the forces of national short-sightedness and religious fanaticism have produced the Iran-Iraq war, the war in Sri Lanka and the struggles in India and Middle America while the bloody controversies in South-Africa, Northern Ireland and elsewhere still continue. The United Nations Organization has been utterly impotent to

prevent or bring these conflicts and clashes to an end, while the Unesco as an international educational and cultural institution has since a few years been facing various conflicts and difficulties.

The world situation in the economic field has not been much better: trade and financial manipulations, the stock market crash and the dramatic fluctuations of the American dollar have tremendous repercussions in the whole world.

Besides and above all these the armament race between the nations goes on with unabated fervor, using and spending more and more material and money, while millions are living in poverty and hunger. Meanwhile we witness a continuous proliferation of the production of nuclear weapons among the nations; at present the arsenal of nuclear bomb is already sufficient to destroy the world many times over.

All these conflicts, crises and forces are driving the world into a cul-de-sac that appears to be without any perspectives of solutions in a foreseeable time. Accordingly, the call for a fresh idealistic group of artists, thinkers and intellectuals take responsibility, to envision, foster, and create positive alternatives is becoming stronger; the dire alternatives require more determined and decisive actions.

The information age is drowning us in data. Transportation and communication are bringing about the convergence of all cultures, in confluence as well as in conflicts. We are losing the meaning of ourselves, of our situation, of this wave of history and the determinative role that mankind must play to prevent a new holocaust, and to create a global social and cultural structure, in which mankind can live in peace and harmony in a world of continuous progress.

It is in recognition of these issues and in the urgency of addressing them that we are asking creative artists, thinkers and intellectuals from all over the world to come together in a second conference for art and the future. Since we are convinced that more than the scientist with his specialistic studies and researches, more than the economist with his concentration on direct gain and more than the politician who is bound to temporary power relationships, the artist with his penetrating intuition and his lively synthetic imagination is able to empathize the present situation and with his elan and creative spirit to project a better and more harmonious future for the human race. Moreover through the suggestive and evocative power of his creation, he is more than anybody else able to move his fellowmen and women to act and struggle for the ideas and ideals of a peaceful human community in a unified world.

It is obvious, that in the face of the overall encounter, conflict and amalgamation of societies and cultures with a great variety of traditions and worldviews, caused by the shrinking distances, the conference has to concentrate its efforts to highlight the great possibilities of mutual under-

standing and influence, of syntheses and new creations based on an abundance of materials, concepts and ideas concerning the future.

During this conference we shall lay the groundwork for a continuing international dialogue, plan and set up other world centers, and discuss the possibility of establishing periodically conferences and take part in art festivals in different parts of the world with the purpose of breaking the creative inertia and stimulating the arts to take on the global task appropriate to the need of our time.

It is on the basis of these considerations that we have decided the theme of this second conference will be :

Synthesis and Creativity in the Arts of the Future.

In this context we would like to suggest some ideas to those who intend to contribute a paper for the conference;

- a. Concepts and problems of synthesis and creativity in facing the future.
- b. Description and analysis of pieces of art which represent strong influences of other cultures or original creativity on the basis of a strong synthetic power.
- c. Description and analysis of the great personalities who have achieved strong influences on other cultures, or have created strong and original pieces of art with the utilization of elements from various cultures.
- c. Reflections and projections of possible arts of the future, emerging from the mutual influences of great traditional arts.
- d. Theoretical reflections and investigations on the process of synthetic creativity.

We would be honored if you would join us at our conference.

3. The Organization and Conditions of the Second International Conference on Art and the Future.

The Conference will take place in Bali from November 3-8 1988. Participants are asked to submit their papers before the 30th of September 1988 to enable the Conference Committee to multiply them in time. The registration fee for participants in US\$ 50.00. Participants will receive all the papers of the conference beside free access to all the art performances and exhibitions during the conference.

Information of hotel facilities, transportation, etc. will follow later. We also will send the definitive program of the seminar after receiving your response.


About Petulu Gunung Village

UBUD - BALI - INDONESIA



On the evening of March 18 the Balinese drive all evil spirits and demons out of Bali with noisemakers and torches. Children take a big part in this because it is so much fun. The next day, Nyepi, could be called "the quiet day". No machinery may operate, no fires are permitted, road traffic is not permitted (except in very special cases), etc. It is not a good day to try to get to or from the airport, but it is definitely a nice experience in many ways. If your travel schedule cannot be altered, the above is of no significance to you. But if you can fiddle your tickets to arrive a few days earlier, being here during Nyepi may be of interest to you. Mike Goodman might have some thoughts on this.

Murni does do some bargaining with people who stay for a couple of weeks but it's a matter of mood and whim and needs of the moment. Sorry I can't be more specific but that's the way it works out. As for deposits: we do like the idea but sending money here from the States in a form that we can cash easily without losing too big a chunk of it remains a mystery - so I guess we'll just wait until you arrive. Travellers' Checks will be fine then.

Best wishes, and we look forward to meeting you in March.




