# Ochsner Holiday Fest Set At Canal Place December 4th-7th

**NEW ORLEANS-**A good way to ring in the holiday season this year is with the Ochsner Holiday Festival, a string of fundraising events with a holiday theme.

The fifth annual Ochsner Holiday Festival will be held at Canal Place Shopping Centre from Wednesday, December 4 to Saturday, December 7. The event is a fundraiser for medical research at the Alton Ochsner Medical Foundation with a focus on family entertainment.

Charel Katz of the Ochsner development division said last year's events, including the Jingle Jam, the Patron Party and other related activities, raised about \$53,000 for medical research at Ochsner.

Teddy bear "companions" are required for children attending the event.




