Comprised of oral histories, biographies, autobiographies and social history, the series will offer a rich variety of works that will appeal to the general reader as well as supplement course texts in African American & Ethnic Studies, Women's Studies, American Studies, social science and history.

I added "insurgent" in the first sentence to make it clear that I am talking about resistance politics, and I added "African American" in the second sentence because African American Studies is sometimes distinct from Ethnic Studies (as at Berkeley), and because our first three titles are about African Americans. I have some hesitation about using "foreground" as a verb, but if "highlight" can be a verb then I suppose I haven't strayed too far into postmodern usages.


I have included a preliminary marketing plan, which lays out both the trade and college marketing plans, as well as information about distribution and advertising. Obviously, we will want to advertise the books as a series and realize we will have quite a showcase for some wonderful authors and volumes, all attached to someone as respected and well-known in many circles as Robert. Of course, each book will not always be identically marketed. Many of these books, because of the strong interest among a general readership, will be released first as trade hardcovers, followed a year later by a paperback. In advance of the paperback, professors in African-American studies, ethnic studies, social change, history courses, etc.. will be notified by our direct mail marketing of fliers, offers of desk copies, web promotion, listings in our subject catalogs, and hopefully by the media attention that surrounded the trade hardcover. In other cases, we might jointly decide that a book would be most useful for courses right away, and release a paperback and short-run hardcover. PUBLISHING AGREEMENT

The undersigned ("Author") hereby agrees with Rowman & Littlefield (the "Publisher") to the following terms and conditions in connection with its publishing the below scholarly work:

*Strong in the Struggle: The Story of Lee Brown and Black Labor* <sup>militancy</sup> ~~Military~~ *in the South and West*, by Lee Brown and Robert L. Allen

1. AUTHOR SHALL GRANT TO THE PUBLISHER during the term of the United States copyright, and during any renewal or extension thereof, the exclusive right to publish and sell, including the right to permit others to publish and sell, your work in book form throughout the world in English and all other languages.

2. AUTHOR SHALL DELIVER TO THE PUBLISHER at your expense no later than 12/31/98 two typed, double-spaced copies of your work in final form including photographs, tables, illustrations, and charts; bibliography or bibliographical essay; and all necessary permissions, licenses, releases and consents. All artwork shall be in camera-ready form. The work will be no more than 85,000 words (224 book pages).

If you do not so deliver your work to the Publisher in form and substance satisfactory to the Publisher in its judgment (which shall be final) by the dates specified or at another date agreed to by us in writing (such time to be deemed of the essence), we may terminate this agreement by notice to you, and you shall then repay all amounts which we have advanced to you; such termination, if not caused by circumstances beyond control, shall be without prejudice to any other remedies we may have for breach of contract.

If we elect to submit the manuscript of the Work to our legal counsel for review, then the Work shall not be deemed complete and satisfactory unless and until all changes which may be required by legal counsel have been made by you.

Author agrees to review and approve the copyedited manuscript, to have all approved editorial changes incorporated onto diskettes, and to submit the diskettes along with a clean copy of the final manuscript. We shall send you galleys and page proofs of the Work which you agree to read, revise, correct and return promptly. Author further agrees to prepare an index when the type has been set into final page form. You agree to pay the cost of alterations in type or in plates required by you (other than those due to printer's errors) in excess of 5% of the cost of composition. We will present the corrected proofs for inspection at your request.

3. PUBLISHER SHALL PUBLISH YOUR WORK at its expense in a manner and style and at a price we believe appropriate. All decisions and details as to the publication of the Work, including style, illustrations, time and manner of production, advertisement, and the number of distribution of free copies will be left to our sole discretion.



4. PUBLISHER AND AUTHOR SHALL TAKE SUCH STEPS as may be necessary in their respective parts to secure and preserve a valid United States copyright in the Work and its name. If we deem it desirable we may take such steps in our name or the name of the Publisher to obtain a copyright in other countries. In no event shall the Publisher be obligated to publish a work which, in its opinion, may subject it to any claims from any third party. Without limiting the foregoing, you shall, if we request it, make such changes in your Work as we shall deem necessary, but failure on our part to require or recommend any changes in your Work shall in no way affect your obligations under subparagraph (a) of this Paragraph.

charges) shall be paid in their entirety to the Publisher. Any and all amounts in excess of \$100.00 shall be shared equally between the Publisher and the Author.

(b) You may, upon written request, examine our books of account insofar as they relate to your work.

12. EXCEPT FOR loss or damage due to our own negligence, we shall not be responsible for loss or damage of any of your property, including the manuscript of your work, and our liability for any such loss or damage shall in no event exceed the amount payable to us under any insurance carried by us covering such loss.

17. 21. ALL RIGHTS AND LICENSES granted or assigned by us, pursuant to this agreement, to any division, affiliate, subsidiary, or parent company or successor of Rowman & Littlefield, shall be construed as though the work was still in our hands and all parts of this contract would still be in full force and effect.

22. If there is more than one author of the work, then all obligations and indemnifications are joint and several.



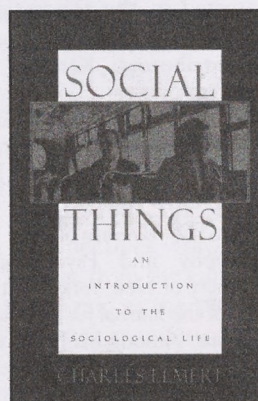

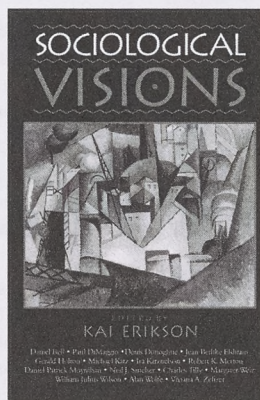

It is liberal in maintaining the emphasis of classical liberalism on individual freedom, moral in adhering to a distinctive vision of the good life rather than professing neutrality, and critical in taking seriously the objection-raised by feminists and Marxists, among others—that liberal theories often serve as ideological cover for oppression of one group by others. Critical moral liberalism has a conception of ideology, and resources for testing the suspicion that arrangements that look free are really oppressive. Reiman sets forth the basic arguments for the liberal moral obligation to maximize people's ability to govern their own lives, and for the conception of the good life that goes with this. He considers and answers objections to the liberal project, and defends liberal conceptions of privacy, moral virtue, economic justice, and Constitutional interpretation. Reiman then takes up specific policy issues, among them abortion, infanticide, euthanasia, moral education,

capital punishment, and threats to privacy from modern information technology. *Critical Moral Liberalism* will be of interest to scholars and students of ethics, social and political philosophy, political theory, and public policy.

Hajdin contends that this perspective is both morally confusing and legally problematic, and sexual harassment can be better addressed by traditional moral and legal categories.

This book re-examines the relationship between development strategy and political regime in twentieth-century Brazil. The first part of the study examines the beginning in the 1920s and 1930s of the centralized regime and state-centered development model later challenged in the 1980s, taking into account the economic and political role of Sao Paulo relative to the federal government. The analysis provides a distinctive account of the regime ruling Brazil from the 1930s through the 1980s. The second part focuses on the process of economic and political change in the 1980s and 1990s, paying particular attention to the Cardoso administration.

The author's analysis of developmental dynamics of the period before World War II challenges the notion that the Vargas state was the main protagonist in the onset of Brazilian industrialization. The concentration of industrialization in Sao Paulo can be explained in terms of social and economic conditions peculiar to that region. The study chronicles the failure of democratizing after the revolution of 1930, probing the connections between the emergence of modern



Brazilian authoritarianism and political dynamics related to regionalism. The account points to continuity in the corporatist system born in the Vargas era through the military era of 1964-85.

Brazilian corporatism and the economic model it embraced came under attack in the 1980s and 1990s. This shift coincides with a period of democratization culminating in the Cardoso administration. Mauricio Font explores the political and institutional factors shaping this transition. He considers whether the economic reforms are leading to a new approach to development and their implications for the consolidation of democracy. Lastly, the volume brings out the broader significance of the Brazilian case for theories of development and democratic transitions.

This interdisciplinary volume explores the social dimensions of state formation and European integration. Offering a novel approach, a respected group of European and North American scholars considers integration as a historical process of

extra-national networks and interest groups within the larger European framework. They argue that integration proceeds in response to transborder movements of people, trade, jobs, and investment. It can be slowed or spurred on by treaties and the mobilization of state interests, but the key elements are non-state actors: unions, businesspeople, elites, and immigrants. This perspective contrasts with the more common view that ties integration to the formation of EU institutions and policy coordination among member states.

In contrast, the post-1989 order has been marked by more fluid boundaries, a fusion of interests, and intensifying conflicts between regions and social groups over growth, the distribution of wealth, welfare, and global access to markets and jobs.

European integration, the contributors argue, neither began nor ended with the Treaty of Rome. Within contemporary integration efforts, they see strands that can be traced back to nineteenth-century social action in response to capitalist development. As today, it was a time when internationalism both that of workers and of capitalists sustained international cooperation and attempts to define universal standards for welfare and a social dimension to economic development. The reemergence of an integrated Europe as an alternative to the system of states produced by the settlements of 1918 and 1945 has provided a new opening for internationalism, a positive trend in the eyes of the contributors.

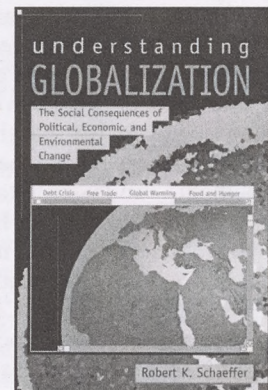

democracy depends on a delicate balance between individual and societal rights. Appeals to the *collective* rights of national and religious groups rest on what Ramet argues is a spurious claim that goes beyond those rights already assured under the rubric of individual and societal rights. Exploring the situation of Hungarians in Slovakia, Albanians in Kosovo, theocratically inclined Catholic bishops in Poland, Serbs in Croatia, and contending forces in post-Dayton Bosnia, Ramet contends that the terms of dispute in these cases can be deceptive. She illustrates that claims made on the basis of what she calls the doctrine of collective rights actually subvert the liberal democratic project. Indeed, where liberal democracy requires tolerance as an essential part of its moral foundation, the doctrine of collective rights legitimates forms of intolerance and group exclusivity, whether in hegemonist or autonomist forms.

As we approach the millennium the world is experiencing civil wars exclusively—half of which are being waged over the issue of secession. This book offers a comparative view of nine historic separatist movements, some of which have achieved the break-up of an empire or a state, and others that to date have not.

Separatist struggles occur in waves that tend to coincide with upsurges of democratization. Several chapters explore this connection, making comparisons with economic and geopolitical causes. The authors analyze the long term effects of secession: after partition, ethnic strife typically continues for generations; minorities decline in status; and democracy and human rights are derogated. The break-up of one state often leads to

further fragmentation, as in the disintegration of the Ottoman, Austro-Hungarian, and Russian empires, where years later separatism unfolded in the successor states of Yugoslavia, Czechoslovakia, Palestine, Chechnya and Tatarstan.

The authors attribute much of today's separatism to the demagoguery of politicians losing legitimacy in post-communist states, for whom nationalism is a convenient populist ideology. A broader explanation, however, points to the failure of modern democracies to develop constitutional mechanisms reconciling the expression of particularistic identities with the universalism of citizenship. 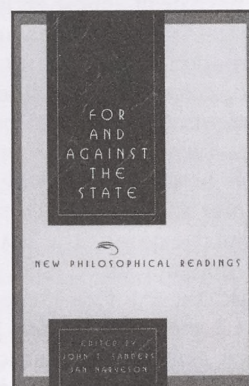

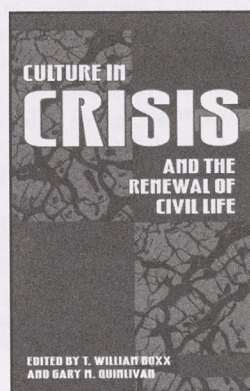

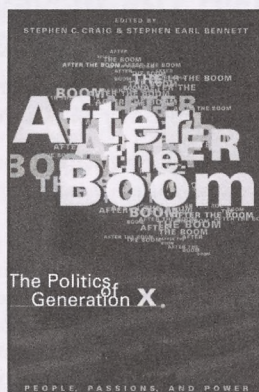

## RELUCTANT MODERNITY

### The Institution of Art and Its Historical Forms

By Aleš Debeljak

**I**n this book Aleš Debeljak offers a refreshing alternative to postmodernists such as Baudrillard who declare the death of art conceived as yet another source of rootless, circulating fictions.

Inspired by the melancholy critical theory of Adorno and Benjamin, and drawing on Weber, Debeljak shows that with the dawning of modernity, art was made autonomous—art production was effectively emancipated from the exigencies of everyday life and its guiding ideal of purposive rationality. The Renaissance brought on the first stage in a long, gradual withdrawal of art from the hitherto dominant mythological, religious, and aristocratic legitimization. Yet it was not until the 18th century that art assumed the separate status of a commodity to be bought and sold. But art paid a price for its autonomy; through commodification art production ultimately become an extension of capitalist logic and control.

The deterioration of bourgeois liberal individualism into the narcissism of mass society accompanied the decomposition of art into propagandistic mass art and commercialized kitsch. Maintaining its formal autonomy (museums, galleries, etc.) its content became the universal object of indirect corporate exploitation. Today postmodern art, says Debeljak, is subjected to infinite reproducibility, total integration into mass society, and political resignation—no longer representing an alternative reality. The postmodern institution of art thus cannot be simply cured of modern structures and assumptions, but is, instead, fated to a continuous and painful relationship with modernity.

**C**an corporations remain socially responsible in today's fiercely competitive global economy? For several decades after World War II, companies like IBM, which exemplified what journalist Robert J. They propose

## Forthcoming FEELING AND FORM IN SOCIAL LIFE

**D**espite the significant contributions of Durkheim, Freud, Kroeber, Mead, Asch, Giddens, and others, social science remains uncertain about its founding idea of society. There is little certainty about what, if anything, is created when people come together in a romantic pair, a family, a club, a work team, a business corporation, or a nation state, which only leads to important philosophical problems for social scientists and practitioners.

*Feeling and Form in Social Life* shows how a vigorous and practical science of society can be built. Drawing in part from the philosophy of Susanne Langer, Lloyd Sandelands reveals human societies to be forms of life known intuitively as feelings of a whole rather than as observed interactions of persons. These feelings, which are personal and subjective, are made public and objective by the uniquely human capacity for artistic abstraction. Through art people turn invisible feelings and forms of society into visible objects and performances that can be shared and studied scientifically.

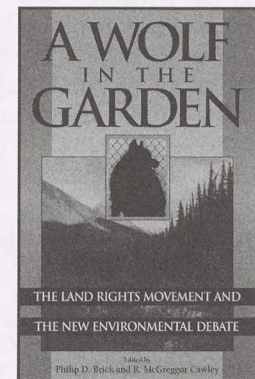

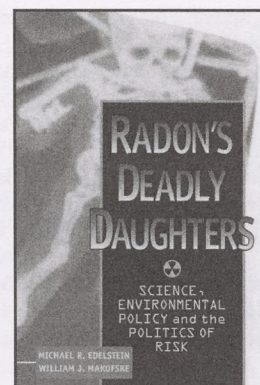

## RADON'S DEADLY DAUGHTERS

### Science, Environmental Policy and the Politics of Risk

By **Michael R. Edelstein** and

Five years after Three Mile Island awakened Americans to the dread of radioactive release, a new and potentially more consequential radioactive threat was discovered in a Pennsylvania home. Touted as the second major cause of lung cancer, the radon problem was promised prominence as a leading environmental risk. However, widespread acceptance of this risk has never materialized.

The story of radon is a parable of the modern ambivalence over environmental risk. In this vibrant account, Edelstein and Makofske unveil the complex mix of social and scientific factors that have led to public and official misunderstanding of the geologic radon issue. The EPA's approach to dealing with radon was embedded in a Reaganomic context that determined how the issue should be handled. At first, radon appeared to Reagan administration officials the "perfect" environmental threat—a naturally occurring risk not caused by corporations or technology. Responsibility for acting on radon could be decentralized to the states and ultimately to the private homeowner with the assistance of a new radon private sector. In this way, costly regulation and a major government role in addressing the risk could be avoided. The resulting program could represent a new paradigm for dealing with



environmental threat, the perfect test of a Reaganomic approach that lives on in the politics of the 1990s.

The outcome of the story, as crisply described in *Radon's Deadly Daughters*, illustrates how risk factors are surrounded by mythic beliefs that contradict scientific realities, how public perception of risk may fail to be motivated even by serious threats and how the political and scientific influences behind environmental policy can seriously undermine an effective response.

The lessons of radon have great relevance in a contaminated world where people are increasingly surrounded by invisible environmental hazards, where uncertainty and controversy shroud a clear understanding of the threat and where one can choose apathetic acceptance or attempt to discern how to actively protect oneself and one's family.

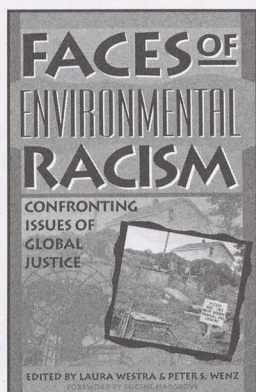

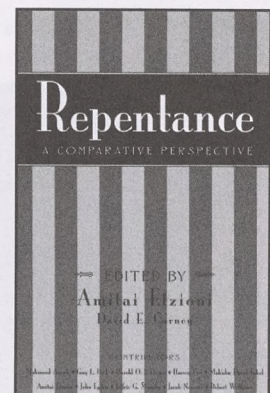

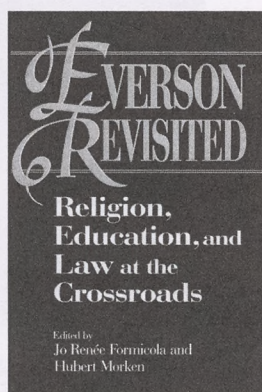

**S**ocial criticism today must respond to rapidly evolving and deep structural changes of global proportions—changes that require new understandings of social, political, and moral life.

Many believe, with good reason, that social foundations are being reshaped by forces that compromise prospects for social survival among those suffering in the world's most poor regions, including the poorer sectors of even the most advanced societies. The changes are so severe as to threaten even those struggling to hold their ground in the traditionally secure middle classes. Virtually every society on the globe must contend with the undeniable moral and social contradictions of the late modern world. Information travels fast and far to all corners of the earth. Yet, more often than not, the flash of communications technologies brings bad social news. The hopes of those who struggle against economic and social injustice are frustrated to the point of social death by a pervasive decline in the natural, economic, and social resources necessary to decent human life.

All too often these crises are defined by reference to the erosion of the traditional foundations or, at the other extreme, by an unthinking celebration of the emergent politics of identity. The basic fact is not that there are no moral or social foundations, but that new ones only vaguely understood are surfacing to challenge common beliefs. These changes will not be understood without a willingness of social critics from the arts, social sciences, humanities, and politics to rethink the world in concepts and language different from those customarily used.

The *New Social Formations* is a book series that encourages this reconsideration. We seek authors, whether well-known or just coming into their own, who are prepared to experiment with different ideas and terms in order to reinterpret such basic human experiences as work and family life, culture and identity, education and knowledge, economic opportunity and limits, political and moral life, sexuality and intimacy, spirituality, and the very idea of the human condition. Authors are invited to write books short in length, free of jargon and technical excesses, and truly accessible to a wide range of readers including college students, policy makers, and the civic minded book lovers. Good and powerful writing, inventive thinking, and compelling moral and political logic are chief among the literary qualities sought.
