robert -- i will be in the bancroft tomorrow and am not certain of my schedule next week. if you need to look at something together, i could probably coordinate that. here are specific things you asked for:

the deal is that most of the collection is in nrlf, so that if you want look at it, you have to order boxes ahead of time from the circulation desk. usually it takes about a day to page them. i will be there tomorrow and can page a couple of boxes for you that would be most relevant. this way you can view them next week. normally they hold boxes for two weeks. also, the full guide for the record appears on line so that you can look through it ahead of time, if you want to familiarize yourself with the collection. that's what i did today, i looked over it and made a list of the boxes/folders that i thought would be most relevant for you. some of the folders i chose state dellums directly and others simply are on topics that

dellums should have been involved in. that's why i wanted to know the exact details of what he was doing with the naacp and which branches he was working with. we will have to piece together his activities through different sets of records i think, because his correspondence file is simply not that extensive. it would probably save time if we can make a more exact timeline of exactly what we was doing with the naacp first.

i apologize, by the way, the pathfinder citation i sent you earlier is for a later collection: the additions which were just recently opened. they start in 1965, and might have some material. but this earlier collection should be more useful to you. perhaps this is what caused the confusion.

>naacp from a newspaper obituary. I should have known better; never trust >newspaper accounts! In his oral history (pp. 87-88) what dellums says is >that he thinks it was in the 1930s that he became vice-president of the >"northern california branch naacp" under walter gordon. When Gordon was >appointed to Prison and Parole Board by Gov. Earl Warren, Dellums finished >out his term as president. Then he was elected president and remained in this

>position "until I voluntarily stepped down." (no dates given.) During this >period, Dellums says, the branch changed its name to Alameda County Branch

>and then finally to Oakland Branch. I do believe that I saw in one of his  
>letters that dellums referred to himself as something like "west coast  
>coordinator" of the naacp, which is different from regional director. He may  
>could have held such a post (perhaps informally) given that his frequent  
>travels around the Coast for the bscp would have made him ideal as a naacp  
>"west coast coordinator." I'll look for that letter when I'm back at Bancroft  
>on Tuesday.
