The City Government passed no resolutions nor ordinances regarding the Japanese, as it was considered ably handled by the Army and the F.B.I.

Several weeks ago, when rumor spread that Japanese selected for release from concentration camps might be

permitted to return to this district to aid in agriculture, a sort of town meeting was held, sponsored by the Chamber of Commerce and the Rotary Club, and resolutions were unanimously passed, expressing the unanimous thought that it was extremely dangerous to permit such an occurrence in the Costal Defense Zone. The danger of sabbotage to vital defense plants, electric transmission lines, power plants, inflammable forests would be such that additional guards to offset the exposure, would by far, exceed the man power brought in to aid agriculture.

It seemed to the undersigned that it was the unanimous view, that this community is glad to be rid of the Japanese and that we wish that they would never return. But the section in the Amendments to the Constitution of the United States relating to protection to Citizens, and the forbidding to States to prevent the granting of citizenship because of "Race, Color or Previous consition of servitude"
