The document is signed "Fidei causa Viri 1.º de la casa de la Torre" and by formula of Charles V lacks his signature. Likewise, the document lacks the royal seal, though the space was prepared for it on the right. Ximén Pérez de Figueroa (1470-1538) was a nobleman from Valencia; he often variously written as Ximéne, Jimén, or Ximés, was vice chancellor for Charles V for the kingdom of Aragon, and even was appointed as viceroy of the Kingdom of Mallorca.
