Various royal decisions are communicated, including rulings against Michael de la Torre and Joannes de la Torre. The document is signed "Figueroia Vict. I." but the space following the titulary formula of Charles V lacks his signature. Likewise, the document lacks the royal seal, though the space was prepared in ink outline. Ximén Pérez de Figueroa (Valencia 1470-Mallorca 1538), whose name is often variantly written as Eximén, Jimén, or Ximén, was vice chancellor for Charles V for the kingdom of Aragon, and eventually was appointed Viceroys of Mallorca.
