(E.S.G. had an after-school job typing papers for a law firm in Palo Alto. He attended high school in Palo Alto in 1908.) undated. 1
- TS. Typed manuscript refers to life as it is. This manuscript is also typed on paper from the offices of S.W. Charles, Frederick Schneider, Attorneys at Law, Palo Alto. (E.S.G. had an after-school job typing papers for a law firm in Palo Alto. He atttended high school in Palo Alto in 1908.) undated. 3ll
- TS. Typed poem about an attorney, author unknown. Handwritten note indicates typist is practicing on new typewriter, note initialed C.K., possibly Cara Keech. Heading on paper is Gates Iron Works, company has many offices listed. undated. 2ll
- TS. "James J. Jimpson, Witch Killer" is a story about a boy who leaves home and opens an office in a small town, saves the townspeople from a witch, and gets back home before his parents return home from Europe.
