# Organizational Information

In 1983 CLMP was created to provide observations and share information regarding law enforcement activities in Southern Humboldt and Northern Mendocino counties in

California. The law enforcement activities, especially CAMP (Campaign Against Marijuana Planting), centered on the marijuana/cannabis growing underway in that region in an attempt to interrupt it. The community felt under siege. Meetings were held and legal actions contemplated. It was necessary to become a non-profit organization to take a legal stand against these law enforcement activities.

# Bonnie Blackberry's fuller history of CLMP and of Citizens' Observation Group is included at the end of this Collection Guide.

#### Abstract

Three separate but related parts are included in this Civil Liberties Monitoring Project Collection: Office files, audiotapes (most from radio shows aired on KMUD), and the 2016 CLMP website that, since 2018, is hosted on the Humboldt Area Peoples Archive webpage. CLMP started in 1983 as the Southern Humboldt/Northern Mendocino community's reaction to ongoing and intensive law enforcement activities aimed at interrupting the marijuana/cannabis cultivation.

#### Access

Only the files are open for research by appointment. Appointments can be arranged by contacting the Archivist. The tape recordings will be available after they are digitized/reformatted.

#### Acquisition Information

In 2018 the audiotapes were transferred to HAPA. In 2019 the boxes of CLMP files and the one box of Mark Drake files were brought to HAPA's office. In 2021 Bonnie Blackberry signed HAPA's Deed of Gift form donating all the materials to HAPA.

#### Funding

Processing the collection was done by Edie Butler on a volunteer basis. Funds are needed to digitize/reformat the audiotapes.

# Arrangement of Collection

The CLMP files were somewhat rearranged to bring like materials together; such as Board of Director minutes and notes, CLMP's newsletters (The Civil Libertarian), compassionate use/medical marijuana materials, voting information. The contents of each file were left intact except for inserting nearby loose materials that pertained to the subject of the file. Other loose materials were put in folders and the title created by the Archivist is stated in [ ] brackets. Multiple copies, beyond two copies, of materials were discarded.

Mark Drake focused his activities on the California Highway Patrol's activities and kept separate files though he worked in tandem with CLMP. His files have been kept separate from CLMP's and are located after the CLMP files, in Box 4.

#### HISTORY OF CIVIL LIBERTIES MONITORING PROJECT

Bonnie Blackberry has provided a history of the Civil Liberties Monitoring Project (CLMP).

CIVIL LIBERTIES MONITORING PROJECT

The Civil Liberties Monitoring Project (CLMP) was formed back in 1983 as part of a community response to local activities and abuses by the combined federal, state and local marijuana eradication program called Campaign Against Marijuana Planting (CAMP).

CLMP is a small non-profit organization, located in southern Humboldt County, relying on community support to continue our efforts. CLMP monitors, documents, advocates for & educates about civil liberties issues in Humboldt, Mendocino and Trinity counties. Our goal is to encourage public awareness of constitutional rights and encouraging involvement of the whole community in preserving and protecting them.

Initially two lawyers in the community, Ron Sinoway and Mel Pearlston, helped to start CLMP and assist in its work to deter infringements by law enforcement including invasions of privacy and illegal search and seizure, as well as environmental degradation.

CLMP became official on October 31, 1983, with initial directors, Nick Licari, Peter Revotskie and Emery A. Burkey. Jared Rossman and Bonnie Blackberry have been on the CLMP Board since the initial directors retired. CLMP has a copy of By-Laws adopted August 29,1995. Other Board members throughout the years have included, Ed Denson, Marie Mills, Bernadette Webster, Michael Deleon, Pav Vanek, Joy Call, Richard Evans, Mark Drake, Tom Oniel, John Hockett, Dora Fales, and Eric Kirk. Current board members are: Bonnie, Jared, Jill McClure and Iona Briefer.

In 1979, Garberville began to receive nationwide media attention after a journalist designated the area, "Pot Capital of California". This same year, Humboldt County was given a federal grant to subsidize their marijuana eradication activities. In 1980, local, state and federal agents participated in a raid of 740 northern California marijuana gardens, called "Operation Sinsemilla."

It was during the summer of 1983 that people in Southern Humboldt communities woke to find themselves under the active surveillance of the Campaign Against Marijuana Planting (CAMP) with armed men in helicopters who hovered above their homes and gardens at tree-top level and circled surrounding fields and forests, with ground activities in local neighborhoods.

Local citizens called a meeting and gathered together at Beginnings octagon in Briceland to consider an appropriate response to this invasion. At this meeting the community members decided we needed legal help to deal with the situation and the Civil Liberties Monitoring Project (CLMP) was formed.

Originally, in 1983, local civil rights attorneys Ron Sinoway and Mel Pearlston made space for CLMP in their office in Redway. After the fire that destroyed their

office we shared office space in a mobile trailer on Rusk Lane, across the street from the Mateel Community Center in Redway. Later we had our office area in a small area of a house in Garberville owned by a board member, Marie Our current (2021) office is at 773 Redwood Drive in Garberville.

In 1984, lawyers Ron Sinoway and Mel Pearlston represented CLMP along with NORML (National Organization for the Reform of Marijuana Laws) and 22 individual plaintiffs to bring an action against various federal, state and local officials in a class action suit for all California residents subjected to the civil rights violations during the Campaign Against Marijuana Planting (CAMP). The court deferred on the class action certification because of the magnitude of manageability problems of this potentially enormous class. The plaintiffs concurred that each case would be tried individually, and the Court issued a preliminary injunction on helicopter and ground activities.

In 1986 the court appointed a monitor to oversee CAMP activities. And finally in December 1987, the litigation was resolved by state and federal defendants consenting to a set of guidelines, 'Consent Degree' to be maintained by all law enforcement during surveillance of and deal with citizens. These were rules to keep both public safety and personal constitutional rights foremost.

CLMP helped bring suit in 1990 against the "Greensweep" military style invasion that occurred in Southern Humboldt on federal land managed by the Bureau of Land Management

1995 Round Valley civil rights case, CLMP worked with San Francisco attorney Dennis Cunningham, interviewing plaintiffs and witnesses collecting declarations, after a shooting which killed a law enforcement officer and a local native American, which resulted in a widespread search on the Reservation.

1996 Headwaters protesters, worked with San Francisco attorney, Dennis Cunningham, interviewing plaintiffs and witnesses, collecting declarations regarding alleged abuses by law enforcement

CLMP has monitored and documented California Highway Patrol's (CHP) questionable activities and citizen complaints, as well as its Drug Interdiction Operations with pretext stops and nonconsensual searches along Highway 101 and on inland county roads during 1995 Harvest Sweep, and Operation North Coast in 1996.

CLMP has also met with the local CHP commanders over the years concerning citizen complaints and we have continued with yearly Civil Liberties Hour KMUD radio interviews with listener call-in.

In1998 CLMP held Know Your Rights presentation at South Fork High School

In 2008 CLMP organized a Town Hall in Garberville on April 4, 2008 with Humboldt County Sheriff, District Attorney, 2<sup>nd</sup> District Supervisor and Code Enforcement officer to bring forth the community concerns regarding the Code Enforcement activities. This was followed on April 8<sup>th</sup> with a presentation, organized by CLMP, at the Board of Supervisors Chambers, which had residents from through out the county voicing their concerns and experiences. (We have audio recordings of these) In response the Humboldt County Board of Supervisors, created the Code Enforcement Task Force, to investigate, and report our findings and recommendations to the Board. (Final report September 26, 2008)

CLMP helped form and participated in the Public Participation Working Group to work on the Humboldt County General Plan Update for several years.

In the last number of years, CLMP has continued its monthly radio program, which is transcribed and printed in the local *Humboldt Independent* newspaper. We have also continued to organize a number of Town Hall community meetings with local law enforcement and county officials.

Currently, in 2021 CLMP is monitoring the Humboldt County Code Enforcement Unit and the commercial cannabis permitting process

CLMP's sources of funding have been: memberships, local fundraisers (Band Wagon events, forums, win-a-trip raffle, sale of T shirts). Also, grants from the Drug Policy Foundation (for the CAMP lawsuit), the Greenville Foundation and Vanguard gave us grants for work monitoring the CHP,

# Citizens' Observation Group

The Citizens' Observation Group (COG) is a separate but related organization.

COG was organized similar to a neighborhood watch, with community volunteers who would go to the places where CAMP and law enforcement were operating

with helicopters and ground crews. The COG motto was, Observe Record and Report. After going through non-violence and observer trainings, which included learning how to take declarations, COG teams would go to the area where CAMP activities were happening to observe, take notes, photos and videos where appropriate. COG would also gather declarations from people who were the subject of law enforcement activities, and/or who witnessed them. CLMP would receive this information.
