Los Gatos attorney Tom Ferrito was Chairperson of the Chapter in the late 1970s.  The bulk of the material was created between 1976 and 1981, but loose Chapter newsletters date to the mid-1980s. In addition to minutes, the records include letters, clippings, and court filings documenting the Chapter's activities during the late 1970s and early 1980s.
