Abstract: The collection consists of watercolor paintings of California native plants by Ruth Brunstetter; lithograph prints of Australian and New Guinea birds by John Gould; watercolor paintings of California native birds by Mary Anna Barker; lantern slides of California native plants by Lustin E. Martindale; photographs, negatives, lantern slides, and other ephemera about California native plants, landscapes, and gardens by Lucia F. Edwards; prints of cacti illustrated by Mary E. Eaton; and artwork and photography by other individuals, mostly used for California Botanic Garden publications or other scientific publications by garden staff.

Biographical Note

Ruth Brunstetter (1926-2010) was an artist, botanical illustrator, and teacher. Brunstetter began teaching botanical illustration at the Cary Arboretum at New York Botanical Garden. She continued to teach botanical painting and illustration at the University of North Carolina Botanical Garden in Chapel Hill from 1984 until 2000. She had numerous exhibitions of her artwork in New York, New England, and North Carolina in both galleries and museums.

John Gould (1804-1881) was an English businessman, publisher, bird collector, and artist. Gould is remembered for his color-plate illustrations of birds. John Gould, together with his wife and lithographer, Elizabeth Gould, published their first collection of artworks in 1832. After Elizabeth Gould's death, he published the seventh and final volume of *The Birds of Australia* in 1848. Gould's lifetime work consisted of over 40 volumes of artwork, with more than 3000 colored plates.

Mary Anna Barker illustrated birds for California Botanic Garden in the 1980s and 1990s.

Lustin E. Martindale (1866-1950) was a commercial photographer and educational artist with the California State school system. He moved to Southern California in 1907 and settled in Los Angeles in 1910. Martindale produced photographs and lantern slides of California native plants for publications, including *Wild Flowers of Southern California* (1926) and *Photographs of Wild Flowers in the Mohave and Colorado Deserts* (1927).

Lucia Fox Edwards (1892-1973) was a landscape architect and photographer. Edwards was born in Madison, Wisconsin, and moved to California with her husband, M. Guy Edwards, in 1922. Edwards photographed California native plants around the California coasts and Santa Barbara area. Edwards also designed gardens and parks in the Pasadena and Laguna Beach areas.

Mary E. Eaton (1873-1961) was a botanical illustrator for New York Botanical Garden. She was the main artist for Britton and Rose's four volumes of *The Cactaceae* (1919-1923), for which she painted 383 full-color illustrations of cacti and more than 300 black-and-white line drawings. Most of her original paintings for *The Cactaceae* are held by the Smithsonian Institution.

Scope and Content of the Collection

The collection contains the artwork and photographs of multiple individuals, including Ruth Brunstetter, John Gould, Mary Anna Barker, Lustin E. Martindale, Lucia F. Edwards, Mary E. Eaton, and others. The subject of the works relate mostly, but not exclusively, to California native plants and birds.

Series I contains twenty watercolor paintings of California native and ornamental plants for the Cultivar Garden interpretive panels and two paintings for the Palm Oasis panel at California Botanic Garden by Ruth Brunstetter. The series also includes a set of notecards with botanical illustrations from 1991 and a set of research documents on Brunstetter. Her art was commissioned by Thomas Elias, the former executive director of California Botanic Garden.

Series II contains 10 lithograph prints of birds of Australia and Papua New Guinea by John Gould. The prints are numbered from No. 601 to No. 610. These reproductions are part of a set titled *Exotic Birds*, published by Sidney Z. Lucas in New York City circa 1930s to 1940s.

Series III contains 12 watercolor paintings by Mary Anna Barker, dated 1997. The illustrations were used for signs for “Common Birds in the Rancho Santa Ana Botanic Garden,” near the Container Garden in California Botanic Garden [Rancho Santa Ana Botanic Garden]. This series also contains an inventory, a photocopy of a pamphlet written by Henry E. Childs in 1989, “Birds of Rancho Santa Ana Botanic Garden, Claremont, California,” with illustrations by Barker, and an interpretation for an unknown display.

Series IV contains approximately 350 hand-painted lantern slides of native California plants by Lustin E. Martindale. Many of the lantern slides are labeled with Martindale’s own series of numbers. The numbers on the lantern slides do not necessarily correspond to the matching photographs in his publications. This series also contains two books by Martindale: *Photographs of Wild Flowers in the Mohave and Colorado Deserts* (1927) and *Wild Flowers of Southern California* (1926), and research documents on Martindale. The lantern slides are ordered alphabetically by species.

Series V contains Lucia F. Edwards’ black-and-white photographs and negatives, lantern slides and glass negatives, dated 1919-1950, of California native plants and landscapes, gardens designed by Edwards, and a trip to Peru. Many of Edwards’ photographs have corresponding negatives. Photographs and negatives follow their original order, except for photographs of gardens designed by Edwards, which are organized alphabetically by location. Most of Edwards’ photographs and negatives come with her original descriptions. A large majority of the lantern slides are unlabeled and depict landscapes that are most likely from around the central coast of California. Series V also contains collection documentation and Edwards’ copies of nursery catalogues.

Series VI contains 174 prints of cacti illustrated by Mary E. Eaton from around 1919-1923, with contributions from Kako Morita, L. C. C. Krieger, H. A. Wood, A. A. Newton; D. G. Passmore, and E. I. Schutt. These illustrations were used for the four volumes of *The Cactaceae* (1919-1923) by Britton and Rose. The collection does not have a complete set of illustrations for any of

the volumes. The prints are ordered by volume number and plate number. In many cases, there are multiple copies of the same print, including earlier annotated versions and the final version. This series also includes a list of illustrations for *The Cactaceae* vol. 2.

Series VII contains artwork and photographs from other individuals, primarily botanical illustrations and photographs used in California Botanic Garden publications or other scientific publications by garden staff such as Robert F. Thorne, Philip Munz, Richard K. Benjamin, and Sherwin Carlquist. Some artists are unknown.
